



Thomas County 4-H Archery State Qualifier

The Thomas County 4-H Shooting Sports Club is hosting a state qualifying event for **Archery** on **Saturday, Aug 9th**, 2025 at the Colby Baseball Diamonds.

Directions: Get off I-70 at exit 54. Proceed north on Country Club to Ninth St and go east to the ball fields. Turn into the ball fields then make a right and follow the trail road around the main diamond to field 5.

Registration will start at 8:00 am CST. The tournament will start at 9:00 am CST.

Event fee will be \$15.00 for the 1st discipline, \$5 for each additional discipline.

The minimum age to participate at the State Match is 9 years old before Jan. 1, 2025

Junior Age Bracket: 9-13; Senior Age Bracket: 14-18

FITA Course of Fire: 4ft. FITA targets: Shoot 24 arrows outdoors at a state match committee approved event. Practice will consist of 6 arrows at 40 meters for Seniors and 6 arrows at 30 meters for Juniors prior to competition. Archers will have a total of 4 minutes to shoot each 6 arrow ends. 2 minutes is allowed to look for lost arrows after each end.

Juniors: 12 arrows at 30 meters and 12 arrows at 20 meters.

Seniors: 12 arrows at 40 meters and 12 arrows at 30 meters.

3D Course of Fire: (possibly) Juniors and Seniors will shoot one arrow at each of 20 targets.

These targets will be set at undisclosed, varying distances from 5m to 20m. Only one archer at a time will shoot at each station. Arrows must stick into the target to count (no bouncing arrows into targets).

Qualifying scores required: (only FITA scores will be counted towards qualifying)

Recurve – Bare Bow: 120 out of a possible 240

Recurve – Olympic: 140 out of a possible 240

Compound – Bow Hunter: 200 out of a possible 240

Compound – Open: 210 out of a possible 240

Certificates will be awarded to the top three archers for each discipline and age group for FITA and 3D.

Entry forms are due by August 1, 2025.
